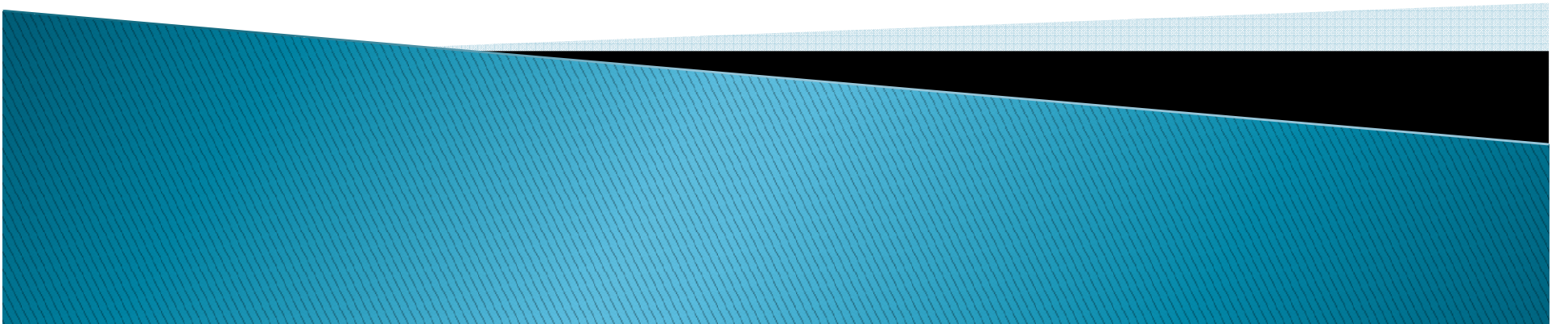

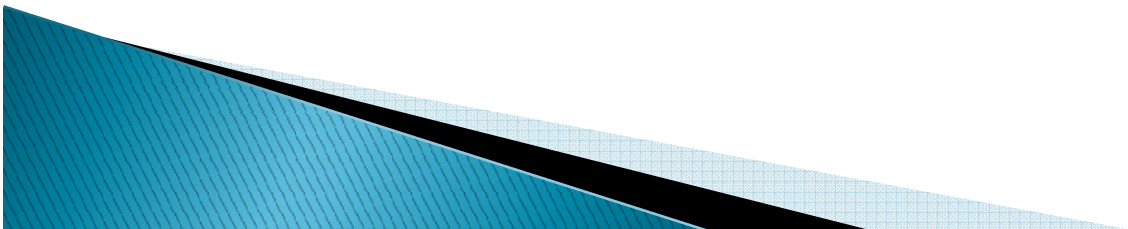

The Erasmus National Agency has rejected our application with the following comment:

I.A Submission of the application

6. Four certified copies (signed, dated and stamped) of original, authentic DS, which were issued to students who have graduated from the applicant institution, are enclosed: NO

We asked the Erasmus National Agency for the reason of NO. They say the Examples of Diploma Supplement issued are not signed, dated and stamped.

However as seen from the attached files our four examples of certified copies of Diploma Supplements have been signed, dated and stamped. We have prepared our Diploma supplement based on Guidelines for Application (ECTS and DS Labels) published by the European commission.

We are kindly asking you to forward our application form and enclosures to your expertise to examine for any problems. If it is needed please let me know that I will also send a copy of the document by regular mail to your address.

It is also will be a good opportunity for us if the European commission gives the option to apply for DS and ECTS labels to the commission directly.

I would like to thank you in advance to consider our case.

Thank you for your email with attachments.

We have looked into the case reported by you and have also been in contact with the LLP/Erasmus coordinator at your National Agency.

We note from the information provided to us that the copies of Diploma Supplements submitted with your application were signed, stamped and dated in section 7 as required for the issue of the Diploma Supplement.

However, the submitted copies were not separately certified as required for the purpose of the submission of a Label application. The application form, page 4 states that 'Certification is to be given by means of one official stamp, signature and date of the applicant institution (per each DS copy provided)'.

- Issued by the applicant institution in 2008 or 2009 (up to 15 January 2010).

Diploma Supplements must be provided for:

1. Two students in different subject areas after completion of their first cycle studies

AND

2. Two students in different subject areas after completion of their second cycle studies

OR

One student after completion of his or her second cycle studies and one student after completion of his or her third cycle studies.

Applicants must ensure that four Diploma Supplements are provided in total.

Only in the event that the applicant institution has only a one cycle programme, Diploma Supplements must be provided for:

- Four students after completion of their studies in different subject areas.

Only in the event that the applicant institution has less than four subject areas, Diploma Supplements must be provided for:

- Four students after completion of their studies in all subject areas available at my institution.
